Report Narrative SOURCE: Dispatched to 4503 Ormond Rd on a Family Trouble complaint.  
INFORMATION: Deputy Kujawa and I arrived on scene and met with Lindsey Atkins. Lindsey was crying and visibly upset. Lindsey states she and her father, Richard, got into an argument in her bedroom. Lindsey states Richard then became physical causing a 1/8 inch scratch to occur to Lindsey's back. All parties were separated and interviewed.  
INTERVIEW WITH VICTIM: Lindsey Atkins: Lindsey states her sister Madyson, was talking on the phone downstairs with her boyfriend. The boyfriends little sister named Lindsey then got on the phone and Madyson told her to get off the phone. Lindsey states that Richard Atkins thought Lindsey was on the phone so he came upstairs and asked Lindsey where the phone was. Lindsey states she told Richard that she did not have a phone. Lindsey states Richard then grabbed her by the shirt and again asked her where the phone was. Lindsey states Richard then pushed her and choked her. Lindsey then told Richard to get away from her and she threw a remote control at him. Lindsey then tried to leave the room and Richard would not let her leave. Lindsey then was able to get around Richard and get to a phone where she then called 911. (see attached witness statement)  
INTERVIEW WITH WITNESS: Madyson Millard: Madyson was on the phone with her boyfriend when her boyfriends littler sister, Lindsey, got on the phone and started signing. Madyson told her to get off the phone. Richard thought it was Lindsey Atkins on the phone. Richard told Madyson to get off the phone and she did. Madyson went upstairs to the bedroom where Lindsey was. Madyson states Richard came upstairs and asked Lindsey where the phone was. They stated there was no phone in the bedroom. Madyson states Richard grabbed Lindsey by the shirt and started swinging Lindsey around. Lindsey tried to get away from Richard. Lindsey then threw a remote control at Richard. Richard then came after Lindsey, started choking her and then threw her up against the bedroom door. Lindsey then tried to exit the room but Richard was blocking it. Devin finally pulled Lindsey through the doorway while Richard was trying to grab her. (see attached witness statement)  
INTERVIEW WITH WITNESS: Devin Millard: Devin states Madyson was on the phone when her boyfriend's younger sister, Lindsey, got on the phone. Madyson told her to get off the phone. Richard thought it was Lindsey Atkins on the phone. Madyson came upstairs and told them what

Richard said. Richard came up a few minutes later. Lindsey was on the computer when Richard pulled her out of the chair and asked her where the phone was. Richard then grabbed Lindsey by the neck and threw her onto the ground, walls and doors. (see attached witness statement)

INTERVIEW WITH SUSPECT: Richard Atkins: Madyson was on the phone and she told Lindsey to get off the phone. The phones have been taken away from up stairs and away from Lindsey and Devin because of the misbehavior. Richard went upstairs and demanded the phone from them. They did not turn the phone over to Richard. Richard screamed that he wanted the phone. Lindsey said "Fuck This" and tried storming out of the room. Lindsey slammed into Richard to try and push Richard out of the way so she could leave the room. Richard pushed her back away from him and Lindsey fell over the bed and fell on the floor. Lindsey then threw a remote control at Richard. Richard states Lindsey then "went crazy" whereas Richard grabbed her by the shirt where she then tried to spin away from Richard. Lindsey then ran downstairs and dialed 911. Richard states Lindsey is incorrigible and unruly at home and school. Richard states he has already been in contact with Probate Court to get Lindsey listed as incorrigible. (see attached witness statement)

ADDITIONAL INFORMATION: Jodi Atkins arrived at the residence while we were there. Jodi states Lindsey is out of control and it incorrigible. Jodi states Lindsey and Devin smoke in the house and burned the carpet in multiple places with cigarettes. They invite people over to the house while she and Richard are at work and they destroy the house. Jodi states Lindsey and Devin are out of control and "mouth off" to Jodi and Richard

ACTION TAKEN: I observed a 1/8 inch scratch on Lindsey's back. Lindsey is not sure how she got it on her back. She thinks it was when Richard pushed her into the door knob. Richard and I went upstairs and looked in the bedroom where the incident occurred. We found a hidden cordless phone in the bedroom. The bedroom was Madyson's. Richard showed me the small safe on the floor which he had to buy for Madyson to secure her property. Richard states Lindsey steals from everyone in the household. I asked Richard how Lindsey got the scratch on her back and he said it was from when Lindsey fell of the bed and onto the floor after he pushed her to get her off of him. I did observe a remote control in the bedroom which Richard said Lindsey threw at him. Jodi's mother arrived on scene and took Lindsey, Devin and Madyson for the night to her place. Lindsey's biological mother was not able to be reached. Jodi states Lindsey it at her house because Lindsey's biological mother, Kimberly Elkins, cannot control Lindsey and has had enough of her incorrigibility.

Witness statements obtained and a copy of the report forwarded to the Prosecutors Office for review. A 3200 was completed and faxed with a copy of this report to CPS.

STATUS: Open pending review by Pros. Office.
