Report Narrative

ORIGIN:

Dispatched to 304 Euclid Street Re; Take an assault report. The callers said his girlfriend was just hit by her ex-husband.

INVESTIGATION:

Upon arrival, Deputy met with the listed victim Melissa Travis. Ms. Travis said she went to her ex-husband's home to pick up their young son Anthony. Ms. Travis said she went to the front door, 304 Euclid, and her ex-husband, listed suspect Jason David Betzoldt w/m 9-14-77, answered. Mrs. Travis said suspect Betzoldt stepped out side and pushed her in the chest. Ms. Travis said she fell backwards and almost off the porch. Ms. Travis said suspect Betzoldt then went back inside and closed the door. Ms. Travis said suspect Betzoldt then came back outside and invited her inside. Ms. Travis said she went inside to retrieve her son and started to walk to her boyfriend's car.

Listed witness Buddy Miller said he observed the incident and called 911. Ms. Travis was noted to have redness and a mild abrasion on her upper chest area. Ms. Travis refused medical attention and later completed a witness statement.

Deputy spoke to listed suspect Jason Betzoldt. Suspect Betzoldt admitted to pushing his ex-wife, but only because she tried to enter his home without permission. Suspect Betzoldt said they have one child together and were married for approximately 1.5 years.

DISPOSITION:

Suspect Betzoldt was later arrested for Domestic Violence Assault and Battery and transported to The Macomb County Jail. Ms. Travis was given a Domestic Violence Information Card and departed shortly after her statement. Deputy cleared, no further investigation was conducted.
