1 **Source:** On Patrol

3 **Information:** While patrolling Dixie Highway and Waterford rd. I noticed a Green 99 Dodge Ram Pickup
4 exiting the Sportsmen bar onto Waterford RD. The vehicle did not stop and almost hit the side of the patrol car. I
5 turned my patrol car around and the truck stopped. I approached the driver's side of the truck and noticed a W/M
6 in the drivers seat. I asked for his license registration and proof of insurance. He provided me with his license but
7 had trouble finding the rest of the information. I identified the driver as Robert Malega. I could smell alcohol on
8 his breath.

10 **Interview with Robert Malega:** I asked if he had been drinking this evening. Malega stated "Yes three drinks in
11 about two hours." I asked when he thought his last drink was he stated 5:25. I asked if he would do some
12 sobriety test and he agreed.

14 **Sobriety test:** I instructed Malega I wanted him to walk nine steps heel to toe forward and nine steps heel to toe
15 backwards. He walked nine steps forward but did not touch his heel to toe. He walked ten paces back. Eye
16 Horizontal Gaze: lack of smooth movement and nystagmus at 45 degree angle. I asked Malega to tip his head
17 back and say his ABC's and stop at M. He stated ACDEFHIJKLM.

19 **Action Taken:** I instructed Malega of the PBT law. He agreed to take the test. Malega tested .09. He was placed
20 under arrest for driving while impaired. He was handcuffed behind his back, double locked and placed in my car.
21 He was transported to Oakland County Jail for a breath test. Malega's girlfriend arrived on the scene and he stated
22 he wanted her to take his truck. At 1819 hours I started the fifteen minute observation and instructed Malega of
