Report Narrative				

On 1-12-09 at 2221 hours Officer Hudson and I (Officer Bowen) were dispatched to 6596 Williams Lake road for a domestic violence complaint.

Upon arrival Officers spoke with the female complainant (Sherry Spiller). Sherry said that she and her husband (Jason Spiller) were having an argument over black mold found inside the house. Sherry said that Jason was shouting in her face and then pushed her. Sherry said she shouted at him not to touch her again. At that time Jason grabbed Sherry around the throat and was holding her down. Sherry told her daughter Sierra to call 911. Jason told Sherry that he was gone and left prior to officers arrival. The assault occurred in the living room of the residence. Sherry did have redness on her neck. Sherry declined EMS.

The assault was witnessed by Sherry's two children Jordan Derus (15) and Sierra Fields (10). Jordan wrote out a witness statement.

Sherry and Jason are married and live together at 6596 Williams Lake. Sherry said that this is not the first time Jason has assaulted her. Sherry was given a blue domestic violence card. Sherry was instructed to call 911 if Jason returns. A copy of the report along with a 3200 form was faxed to child protective services.

Officers did check Watkins Lake road near Pontiac Lake for Jason's vehicle (friend's house) but did not locate it. Sherry did not have an exact address.
